**SCHEDULING ORDER FOR RESPONDENTS TO RESPOND TO AGENCY'S
MOTION TO CONSOLIDATE CPSC DOCKET NUMBERS 12-1/12-2 AND 13-2**

On December 17, 2012, counsel for the Consumer Product Safety Commission (“CPSC” or “Agency”) filed a Motion to Consolidate CPSC Docket Nos. 12-1/12-2 (In re Maxfield and Oberton Holdings, LLC/In re Zen Magnets, LLC) with CPSC Docket No. 13-2 (In re Star Networks USA, LLC).¹ Agency counsel served the Motion to Consolidate on all Respondents.

On October 30, 2012, I issued an order consolidating CPSC Docket Nos. 12-1 and 12-2 in my capacity as Acting Chief Administration Law Judge because the cases had been assigned to two different presiding judges. That order assigned the consolidated cases to the Hon. Dean C. Metry.

In order to maintain procedural consistency with respect to the current Motion to Consolidate, I will render the decision on that motion, even though Docket No. 13-2 has already been assigned to the Judge Metry.

Generally, under 16 C.F.R. § 1025.23(c), a party has ten days after service of a motion to respond. However, due to the unique procedural posture of these cases and my rendering the earlier decision on consolidating CPSC Docket Nos. 12-1 and 12-2, I am modifying the time for Respondents to file a response as outlined below.


WHEREFORE:
