THE BLADE ON MY SAW HAD JUST BURNT UP AND I WANTED TO FINISH MY PROJECT SO I WENT TO MY NEIGHBOR'S HOUSE AND BORROWED HIS. SINCE IT WAS NOT MY SAW, I DIDN'T REALIZE THAT IT WAS BIGGER THAN MINE AND THUS THE BLADE WAS LARGER. THE WOOD WAS JUST STARTING TO KICK SO I PUSHED DOWN WITH MY RIGHT HAND AND THE BLADE BEING LARGER CUT MY THUMB. I NOTICED THAT IT WAS BLEEDING SO I TOOK MY FINGER AND PUT IT IN THE PALM OF MY HAND AND SQUEEZED IT TIGHT TO STOP THE BLEEDING. THEN I WRAPPED IT IN A CLEAN RAG AND USED SOME TYPE OF TAPE TO SECURE IT TIGHTLY. IT WAS NOT LIFE THREATENING SO LATER I DROVE MYSELF TO THE HOSPITAL TO HAVE IT LOOKED AT.

MY LEFT HAND WAS ON THE END OF THE WOOD THAT I WAS PUSHING INTO THE SAW. MY RIGHT HAND WAS HOLDING THE WOOD DOWN ON THE TABLE. I MOVED RIGHT HAND AROUND THE SIDE OF THE SAW TO PUSH DOWN ON THE WOOD WHEN IT STARTED TO JUMP. AT THAT TIME I WAS STANDING TOWARD THE RIGHT SIDE OF THE SAW, HOLDING THE WOOD WITH MY LEFT HAND AND PUSHING DOWN ON THE WOOD WITH MY RIGHT HAND. IF IT HAD BEEN ON MY SAW IT WOULDN'T HAVE HAPPENED BECAUSE THE BLADE IS SMALLER. I WAS HOLDING THE WOOD FIRMLY WITH MY LEFT HAND
