Dear Sirs,

On February 19, 1995 my family came home from church with guest for lunch. I had already cooked a sweet potato casserole in a 2 quart amber Anchor Hocking Glass baking dish and had left it in the oven. I removed the casserole from the oven and placed it on the eye of the stove and a pot of green beans on the eye directly behind it. I turned on the eye under the potato casserole instead of the green beans. I turned to the refrigerator to remove another vegetable and moved to the sink, there was no more that two minutes in lapse of time between the time I turned on the eye under the potato casserole and the casserole pan EXPLODED it did not break but shattered into thousands of small pieces and shattered all over the kitchen. Some of the fragments hit me in the back and a great many landed on the kitchen floor. About half of the shattered pan hit the floor and burned the tile, the tile is one piece and covers an area of about 1200 sq. ft. We are having it replaced, our house is about two years old; the home owners policy is replacing it but there is an deductible of \$250.00.

At the very least I believe you should pay the deductible, if you wish to get in touch with my insurance company I will provide all the necessary information you need.

I believe I could have been severely injured had I been standing over the stove and had not been at the sink with my back to the stove.

I have saved the most of the fragments of the pan and can send them to your engineer if you wish.

We have received your letter and we are sorry to learn of the problem you have experienced with your Anchor Hocking ovenware.

If you will refer to the attached Care and Use instructions, which are also printed on our ovenware packaging, you will note that we do warn consumers against stove top and/or broiler use. In addition, the bottom of our ovenware products also have this warning molded into each piece. As was indicated in your letter, your ovenware was subjected to stove top use. Because this was clearly misuse of the product, we cannot be responsible for any of the damages incurred.

I would like to report an incident that happened in the use of an Anchor Hocking baking dish. I used the dish in the oven and removed it to the top of the stove to cool. After I emptied the contents, I then placed it in an empty sink to be cleaned later. It had been in the sink only a few minutes when it exploded into dozens of pieces of various sizes. It frightened everyone in the kitchen. There were small children in the house and could have been seriously injured had they been in the kitchen. I know of others who have had a similar experience. A more prominent warning of a possible hazard should be given about this product.
