Dear Judge Foelak:

This letter confirms that the Office of the Personnel Management has approved the U.S. Consumer Product Safety Commission's ("CPSC") request to the U.S. Securities and Exchange Commission ("SEC") for the loan of an Administrative Law Judge ("ALJ") to preside over the administrative adjudication captioned *In the Matter of Amazon.com, Inc., CPSC Docket No. 21-2*. I was pleased to approve your appointment under Section 4(f)(1) of the Consumer Product Safety Act ("Act"), 15 U.S.C. § 2053(f)(1). On September 6, 2022, CPSC voted unanimously to ratify your appointment as presiding officer in Docket 21-2. Therefore, the loan of your services to CPSC under terms and conditions prescribed in 5 U.S.C. 3344 and 5 C.F.R. § 930.208 has been ratified.

The complaint initiating this proceeding was issued July 14, 2021, and was published in the *Federal Register* on July 21, 2021. The complaint seeks public notification and remedial action pursuant to the Consumer Product Safety Act, 15 U.S.C. § 2064(c) and (d). On September 10, 2022, the current presiding officer, Judge James E. Grimes, will depart from the SEC and, accordingly, from this adjudication. Your appointment is effective upon Judge Grimes' departure. CPSC's Rules of Practice for Adjudicative Proceedings can be found at 16 C.F.R. part 1025.

Because your predecessor on this matter was also an ALJ with the SEC, the inter-agency agreement between CPSC and SEC's ALJ Office remains operable. Nina DiPadova, Attorney Advisor in the Office of the General Counsel, will be the contracting officer for this matter. Your primary contacts will be Ms. DiPadova, [REDACTED], and Secretary of the Commission Alberta Mills, [REDACTED], regarding the contract or any other procedural matter.

CPSC and I appreciate the assistance of your office and the cooperation of the SEC in making your services available to our agency.
