

NOTICE OF SUPPLEMENTAL AUTHORITY

Respondent Britax Child Safety, Inc. (“Britax”) hereby submits the attached supplemental authority in support of Respondent Britax Child Safety, Inc.’s Response to Order Regarding Appointment, Motion to Disqualify Presiding Officer, and Motion for a Stay Pending Resolution of the Motion to Disqualify (“Britax’s Motion”). The attached is an Order issued by the Securities and Exchange Commission (“SEC”) yesterday (August, 22, 2018) in the matter captioned as “In re: Pending Administrative Proceedings” (“SEC Order”). The SEC Order addresses matters considered during a stay of pending SEC administrative proceedings to consider the implications of the U.S. Supreme Court’s decision in *Lucia v.
