JOINT MOTION TO UPDATE RESPONDENT’S NAME AND CASE CAPTION

Pursuant to 16 C.F.R. §§ 1025.13 and Your Honor’s February 18 Order, Complaint Counsel and Respondent jointly request that the Presiding Officer update the name of Respondent in this action from thyssenkrupp Access Corp. to TK Access Solutions Corp. in order to reflect Respondent’s updated business name.

On February 18, Your Honor ordered, *inter alia*, that “the parties should submit a Joint Motion to update Respondent’s name from thyssenkrupp Access Corp. (‘TKA’) to TK Access Solutions Corp. (‘TKAS’) if there remains no contest that the name should be changed in this proceeding.” There remains no contest that Respondent’s name should be changed in this proceeding.¹

Under the Commission’s Rules of Practice for Adjudicative Proceedings, the Presiding Officer “may allow appropriate amendments and supplemental pleadings which do not unduly broaden the issues in the proceedings or cause undue delay.” 16 C.F.R. § 1025.13. The parties agree that modifying the case caption solely to reflect Respondent’s updated business name will

not unduly broaden the issues or cause undue delay.
