

**MOTION TO EXTEND THE TIME FOR EXCHANGING LIST OF EXPECTED

Pursuant to 16 C.F.R. § 1025.21, this Court held a prehearing conference on July 29, 2013, and issued an order dated July 30, 2013. In that order, the Presiding Officer established that each party would exchange a list of expected expert witnesses by November 15, 2013.

Counsel for Respondent requested and was granted several extensions for filing responses to discovery served by Complaint Counsel. With the accession of Complaint Counsel, Counsel for Respondent filed the last outstanding response for Zen Magnets, LLC on November 4, 2013 and filed the last outstanding response for Star Networks USA, LLC on November 7, 2013. On November 14, 2013, Complaint Counsel discussed with counsel for above Respondents extending the time for exchanging list of expected expert witnesses to January 6, 2014. 
