My January 19 letter listed approximately two dozen examples of rulemaking-related votes (some procedural, others substantive) for which no decisional document was provided. It also noted that decisional documents may also be missing for some (perhaps many) other Commission rulemaking-related votes. Only a small handful of corresponding decisional documents were included in the FOIA Office's February 27 production. • Missing Vice Chairman Elections. The FOIA Office has not produced decisional document reflecting the Commission's vice chairman elections for certain years (including 2002, 2004, 2007, 2008, 2009, 2015, 2016, 2018, 2020, 2021, and 2022). The office stated only that Ms. Mills' search for these documents did "not yield any such record" and that "the Commission did not vote to elect a vice chair in 2018, 2020, 2021, and 2022." Absent further explanation, this explanation is difficult to square with CPSC regulations, which expressly provided that the Commission "shall annually elect a Vice Chairman for a term beginning on June 1." See Ex. A (attached to concurrently submitted email and hard copy). According to reports, the Strollers have broken in well over one hundred instances, sometimes causing infants and toddlers to fall onto streets and sidewalks. Our FOIA request pertained to consumer complaints and the associated recalls of the Mockingbird Strollers overseen by the CPSC. The documents that are being withheld must be disclosed under the FOIA because the documents do not properly fall under any exemption. The CPSC's denial of our request was predicated on FOIA Exemption 7(A), 5 U.S.C. § 552(b)(7)(A), which permits withholding from disclosure only where "there [is] a 'reasonable likelihood' of a pending or contemplated law enforcement proceeding [and] release of the information [is] reasonably expected to cause some articulable harm to that proceeding." U.S. Dep't of Justice Guide to the Freedom of Information Act, Exemption 7(A), 2-3 (Aug. 21, 2019). However, the CPSC's March 6, 2024 letter did not specify how the documents were part of the investigation or law enforcement action and did not articulate how their disclosure would harm that investigation. Moreover, in issuing a blanket denial of all documents under the exemption, the CPSC improperly failed to consider whether certain documents may be produced now, with the balance being produced at the conclusion of any investigation.
