## ORDER TO REDACT AND REFILE CERTAIN PLEADINGS AND EXHIBITS

As ordered by the Commission, on November 27, 2017, the parties submitted a Joint Statement Regarding the Draft Action Plan and Draft Public Notification with accompanying Exhibits A through F (collectively the "Joint Statement"). On December 1, 2017, the Commission, through the Office of the Secretary, directed the parties to clarify, by 3 p.m. on December 5, 2017, whether any of the information contained in the Joint Statement is considered a trade secret, commercially sensitive information, or should otherwise be subject to a protective order. Additionally, the Commission advised Respondent that, to the extent Respondent is claiming exemption of disclosure of any names of foreign manufacturers because they are trade secret or commercially sensitive information, Respondent should provide the Commission with the information required to accompany such a request pursuant to our regulations at 16 C.F.R. §§ 1015.18(c) and 1101.24(b). Each party filed a response on December 5, 2017, as directed (the "Responses").

Having reviewed the record and the Responses from the parties, the Commission declines to decide whether the claimed information meets the requirements for treatment as confidential business information or is a trade secret at this time. The Commission preserves Respondent's claim regarding information in the Joint Statement and attached Exhibits, as follows:<sup>1</sup>

- Each party will redact the claimed confidential business information from the Joint Statement, all attached Exhibits, and the Responses.
- The parties shall refile the redacted Joint Statement, attached Exhibits, and Responses with the Office of the Secretary, no later than 5 p.m. on Friday, December 15, 2017.
