
1. Filed herewith is a Motion to Disqualify the Commission or Some of Its Members and a Memorandum in support thereof and an affidavit in support thereof.
2. Insofar as that Motion requests that the Commission decide it before hearing the appeal, it makes sense to stay the time for Respondent’s Answering Brief.
3. The basis of the Motion to Disqualify is Respondent’s Due Process Rights pursuant to the Fifth and Fourteenth Amendments to the United States Constitution.
4. Staying the appellate proceedings until that motion is decided would be in the interests of justice.


